





# **Mandatory Food Waste Recycling**

#### It's The Law

City & County of Honolulu Ordinance, Chapter 9, Section 9-3.5 requires the owners of food establishments located within the City and County of Honolulu (City) to: 1) arrange and provide for the separate collection of food waste and for its recycling by a recycling facility on Oʻahu or 2) separate food waste from all other solid waste generated by the food establishment and deliver the food waste to a recycling facility.

To be in compliance with City law, restaurants, food courts, hotels, grocery stores, food manufacturers/processors and hospitals meeting the following criteria are required to recycle food waste:

- Restaurant that occupies 5,000 square feet or more of floor area and serves 400 or more prepared meals per day\*
- Food court in a building or shopping center where five or more food establishments are situated and serviced by a common dining area
- Hotel with one or more kitchens, and function rooms
- Grocery store that occupies 18,000 square feet or more of floor area
- Food manufacturer or processor that occupies 5,000 square feet or more of floor area
- Catering establishment that serves or sells 400 or more prepared meals per day\*
- Hospital that serves 400 or more prepared patient meals per day\*

\*Meals per day are based on an annualized average

# **Recycle The Following:**

: All animal, vegetable and beverage waste which attends or results from the storage, cooking, preparation, handling, selling or serving of food.

\*Fats, oils & grease (FOG) is <u>not</u> considered food waste, & should be collected separately. FOG is regulated by the ENV Environmental Quality Division - Regulatory Control Branch (768-3272).

## **Do Not Recycle With Food Waste:**

Plastic, metal, wood, bags, chopsticks, cutlery, glass, cardboard, paper, napkins, produce stickers and landscape clippings\*\*.

\*\*Check with your collector to verify.

## **Going Green Is Good For Business**

Recycling is not only the law, it's also the smart thing to do. It's great for the community and beneficial to your business. Your business can benefit from promoting sustainability, as it is becoming increasingly popular for customers to support green business practices.

Approximately 40% of America's food gets wasted. The number one goal of the US EPA's Food Recovery Hierarchy is source reduction (stopping food waste before it happens). The best thing to do, is to reduce your excess food and food waste. Conduct a food audit by frequently looking at inventory and by storing and labeling properly. Also, consider tactics such as serving smaller portions. The next goal on the Hierarchy is to feed hungry people. Find out how much excess food you can rescue, and donate to people. The remaining Hierarchy steps are to (respectively) feed pigs/animals, render meat/oils, and compost. Reducing and recycling helps to extend the life of our landfill and improve sustainability.

## **Collection Options**

The Bill Emerson Good Samaritan Food Act and the Food Donation Act of 2017 state that donors who give food to nonprofit organizations in good faith are protected from food-safety liability.
